## 2022 National Minimum Wage increase

On 1 January 2022 the National Minimum Wage rate increased to €10.50 per hour.

Category of employee and hourly rate:

- Aged 20 and Above: €10.50
- Aged 19: €9.45
- Aged 18: €8.40
- Under 18: €7.35

In order to ensure that the increase in the minimum wage does not result in employers attracting a higher level of PRSI solely due to the increase, the employer PRSI threshold increased from €398 to €410 on 1 January 2022.

# Public Consultation on the transposition of Directive (EU) 2021/2101 as regards disclosure of income tax information by certain undertakings and branches

The Department of Enterprise, Trade and Employment is currently seeking views from stakeholders and interested parties on the transposition of Directive (EU) 2021/2101 of the European Parliament and of the Council of 24 November 2021 amending Directive 2013/34/EU (the Accounting Directive).

This Directive, which must be transposed by 22 June 2023 aims to enhance corporate transparency and public scrutiny of corporate taxes paid by Multinational Enterprises (MNEs) carrying out activities in the EU.
