New €5m COVID-19 Online Retail Scheme

Applications sought from Irish-based retailers for grants of up to €40k

The scheme closes at 12 noon on Tuesday, 25 May 2021.

The new \notin 5 million COVID-19 Online Retail Scheme is open to eligible Irish-owned retail enterprises that had 10 or more employees on or before 29 February 2020 (or have grown to this level since then) and have the potential to sustain or create jobs, generate growth in online transactions and with an ambition to internationalise their business in the future. Successful applicants will receive a grant ranging from \notin 10,000 to a maximum of \notin 40,000 covering up to 80% of project costs.

Public Consultation on the Right to Request Remote Work

The closing date for submissions is this Friday, 7 May 2021.

The Tánaiste Leo Varadkar T.D. has launched a public consultation on the introduction of a statutory right to request remote work. This consultation will inform new legislation which is a key action under the National Remote Working Strategy, launched in January 2021. Currently in Ireland, all employees can request remote work from their employers but there is no legal framework around which a request can be made and how it should be dealt with by the employer. The background to this initiative is set out in the consultation paper, which also provides an opportunity to provide views on important relevant issues including:

- duration of service before having an entitlement,
- carrying out a risk assessment on a proposed remote working location,
- reasonable grounds for refusing a remote working request,
- the right of complaint,
- provision of necessary equipment,
- monitoring of activity by employers.

Public Consultation on the transposition of Directive (EU) 2020/1828 on representative actions for the protection of the collective interests of consumers

The Department is currently seeking views from stakeholders and interested parties on the transposition of Directive (EU) 2020/1828 of the European Parliament and of the Council of 25 November 2020 on representative actions for the protection of the collective interests of consumers and repealing Directive 2009/22/EC.

This Directive, which must be transposed by 25 December 2022 will provide tools for stopping illegal practices and facilitating redress for consumers where a number of them are victims of the same infringement of their rights, in a mass harm situation. No such system currently exists in Ireland.

Annual Employment Survey 2020 and Annual Business Survey of Economic Impact 2019

The Department of Enterprise, Trade and Employment published the Annual Employment Survey 2020 and the Annual Business Survey of Economic Impact 2019. DETE co-ordinates these surveys of the client companies of the enterprise development agencies (Enterprise Ireland, IDA Ireland and Údarás na Gaeltachta). The results are presented by company ownership in terms of Irish and foreign-owned firms.

The indicators collected include annual sales and exports and payroll, materials and services costs. Data collected in 2019 and 2020 is merged with results of previous surveys to provide trend data and indicators are available by ownership and sector and are used by the agencies in their annual reports and end-of-year statements.

Key results include:

- Employment in Enterprise Ireland, IDA and Údarás na Gaeltachta supported companies amounted to over 485,903 jobs in 2020, their highest ever level, accounting for one third of total business employment in Ireland.
- Total employment in agency client companies increased by 1.7% since 2019, an increase of 7,453 jobs.
- During 2019, sales, exports, value added, and direct expenditures in the Irish economy all showed strong growth for both Irish and foreign-owned companies.

First meeting of the Regional Enterprise Plan National Oversight Group

The Department's Ministers of State Damien English T.D. and Robert Troy T.D., have convened the first meeting of the Regional Enterprise Plans National Oversight Group. The Group has been established by the Department, to guide and oversee preparation of the new Regional Enterprise Plans to 2024 at the national level. Following development of the new Plans, the Group will oversee implementation through to 2024.

The Oversight Group which will meet quarterly, includes the Chairpersons of the nine REP Steering Committees, regional Programme Managers, and representatives of Enterprise Ireland, IDA Ireland, local enterprise offices, the City and County Managers Association, Regional Assemblies, Fáilte Ireland, as well as officials from the Department of Rural and Community Development and Department of Further and Higher Education, Research, Innovation and Science.

The development of Regional Enterprise Plans to 2024 delivers an important component in the Programme for Government commitment to adopt a coherent policy approach to the enterprise needs of every part of Ireland. As a 'bottom-up' initiative, led by industry Chairpersons from the region, the Plans also complement national level enterprise policies and programmes.
