Government launches the renewed National Development Plan 2021-2030

On 4 October, Taoiseach Micheál Martin, Tánaiste Leo Varadkar, Minister Eamon Ryan and Minister Michael McGrath launched the new <u>National</u> Development Plan 2021 - 2030 in Páirc Uí Chaoimh.

The publication outlines the largest National Development Plan ever delivered in the history of the State - €165 billion - with a particular focus on priority solutions to strengthen housing, climate ambitions, transport, healthcare, jobs growth in every region and economic renewal for the decade ahead.

This plan will prepare us for population growth of approximately 1 million people between 2016 and 2040 and help us to deal with the ongoing challenges of COVID-19 and Brexit.

Updated Work Safely Protocol

The <u>Work Safely Protocol</u>, the COVID-19 national protocol for employers and workers, was updated on 16 September 2021 to reflect updated Public Health advice and knowledge. The technical updates include the inclusion of new symptoms associated with the Delta variant of COVID-19 and additional information on ventilation, and vaccinations.

This updated Protocol remains a robust document which is applicable to all sectors of the economy. It sets out the **minimum Public Health infection prevention and control measures required** in every place of work to prevent and reduce the spread of COVID-19. It is not designed to prohibit the introduction of additional measures in particular sectors or workplaces which could further enhance the measures set out in this Protocol.

WIPO launches Intellectual Property Diagnostics Resource

The World Intellectual Property Organisation (WIPO) has launched a free, comprehensive self-assessment IP Diagnostics tool designed to help small businesses identify their IP assets and determine how to protect, manage and leverage these assets to unlock new commercial opportunities.

The questionnaire style assessment allows users to learn the basics of IP by reviewing their own business activities and assets. On completion of the assessment, users will receive a customised report that can be used to begin developing an IP strategy.

WIPO IP Diagnostics is a useful tool for small businesses to become acquainted with the practical advantages of the IP system. It can also function as a useful resource for business intermediaries who may rely on it to complement their IP advisory services for businesses.

NSAI's Public Consultation for Irish Standard on Emergency Lighting

The National Standards Authority of Ireland (NSAI) have announced the launch of a period of public consultation on Irish Standard (I.S.) 3217 – Emergency Lighting. The document gives guidelines for the design, installation, commissioning and maintenance of emergency lighting systems.

WIPO Survey on Intellectual Property Support Services to SMEs

Intellectual Property and Innovation Ecosystem Sector (IES) of WIPO is inviting organisations in Member States acting as intermediaries to SMEs to complete a short online survey on the nature and extent of intellectual

property (IP) support services provided by them to businesses and SMEs in particular. Such organisations include government institutions that support SMEs, business associations, chambers of commerce, business support organisations, incubators, technology parks, accelerators, innovation agencies, export development agencies, organizations that support start-ups.

The information collected will be made publicly available in a database which will enable local SMEs to identify sources of support.
