**Objective**: The **Future of Retail – Town Centre First/Night-time Economy** working group is tasked with identifying a set of achievable actions to feed into a Retail Action Plan that will be presented to the Minister for Retail, Damian English T.D. at the Retail Forum meeting on 08 June 2022.

## 1. Agenda Items

The Chair welcomed the members of the working group and thanked them for their participation. Three meetings of the working group will be held in advance of the 08 June meeting and will focus on:

## • Town Centre First

Action 15 - Promote existing exemplars and current models which illustrate successful Town Centre living and explore how to encourage behavioural change

## • Night-Time Economy

Action 15 - Work with the Retail Forum to examine the types of interventions required for late retail opening. Establish a Retail Forum working group to discuss this along with the Town Centre First initiative

A tour de table followed where each member outlined their ideas and suggestions and issues that they believed were important priorities for the group to work through.

DETE outlined its participation in the Department of Tourism, Culture, Arts, Gaeltacht, Sport and Media working group on developing alcohol free activities in the NTE and its proposals. Working group members were invited to contribute to the proposals to feed into the Working Group – particularly from a retail perspective. DETE will continue to update members on developments in relation to the NTE including details of any intended Schemes.

## 2. Issues/Challenges raised

## Town Centre First (TCF) Policy

- 2.6 million on the development of Town Centre Plans in 26 towns is welcome however, concerns exist that the TCF model will result in disparate plans for towns around the country. Consistency in approach throughout the country is required.
- The process of implementing the TCF policy, including recruitment of Town Regeneration Officers (TROs) needs to be business-led.
- Town Regeneration Officers (TROs) will have a demanding role and an important one and will need to have the appropriate skills.

- A suggestion was made to establish a not for profit body akin to Scotland's Towns Partnership to lead on TCF
- It was suggested that the Collaborative Town Centre Health Check Programme could be funded and rolled out nationally and the programme could develop and manage a portal and the collection, collation and management of the data and all TCF initiatives.

## Data (including vacancy rates)

- Lack of data an ongoing issue in Ireland it needs to be addressed urgently.
- A dynamic coherent inventory of vacant buildings is required.
- The Vacant Properties Indicators Model in Philadelphia could be considered. Registry in Ireland is expensive this information should be free.
- Not all vacant premises can/should be re-purposed as retail there are too many retailers in some towns.

## Innovation

- The use of vacant properties in towns requires reimagining for the daytime and night-time economies.
- Promoting the experience economy is important both during the day and at night-time.
- Innovative ideas are needed to bring people, foreign companies, and entrepreneurs into towns.
- Hospitality draws people into towns. Retail can benefit from this by remaining open later and diversifying their offering.

## **Building on Success**

• It is important not to reinvent the wheel -The Purple Flag initiative was commended as an initiative that has worked.

## NTE and TCF

• Ensure that the retail sector collaborates jointly with NTE and TCF offices to avoid duplication.
