

PUBLIC CONSULTATION ON THE NATIONAL ACCREDITATION STRATEGY

The Irish National Accreditation Board (INAB) invites submissions to a public consultation on the National Accreditation Strategy

Introduction

The Irish National Accreditation Board (INAB) is the national body with responsibility for accreditation in Ireland. Working across government with our EU and international partners to achieve progress in EU and international fora, across a wide range of interests, including Brexit.

INAB was established in 1985 and is a Committee of the Health and Safety Authority (HSA) under legislation (Safety, Health and Welfare at Work Act 2005, as amended by the Industrial Development (Dissolution of Forfas) Act 2014.

The HSA is an agency of the Department of Enterprise, Trade and Employment and in 2010, the Department notified the European Commission that INAB was the sole accreditation body for Ireland in line with regulation EC/765/2008.

Background

INAB accredits laboratories, certification bodies, verification bodies, biobanks, reference material producers and inspection bodies. It provides accreditation in accordance with the relevant International Organisation for Standardisation ISO 17000 series of standards.

Accreditation is the independent third party confirmation of competence and is recognised worldwide as a tool to support enterprise, trade and regulation.

Accreditation, which operates across all market sectors, provides an impartial assessment against internationally recognised standards. It offers a single, transparent and repeatable approach which:

- is voluntarily embraced by business;
- reduces the need for central and regional government to employ its own specialist assessment personnel;
- underpins regulations and legislation for consumer protection
- builds business and consumer confidence.

The process of accreditation provides a cost-effective means of delivering public services which:

- are reliable, high quality and safe;
- support regulatory compliance;
- imply lower administrative burdens and bureaucracy.

As part of the Authority's statement of strategy 2019-2021 (<u>here</u>), a critical objective is to grow the national accreditation service and in doing so, develop a national accreditation strategy.

National Accreditation Strategy

INAB has commenced the preparation of the first national accreditation strategy for a fiveyear period. The strategy will comprise the key priorities and objectives for accreditation in Ireland during that period.

The strategy development process involves developing priorities and actionable objectives, informed by input from a wide range of stakeholders including (but not limited to) government, sector partners, clients and other international accreditation organisations.

Though INAB will look to champion the delivery of this strategy, successful implementation will require buy-in across government, market sectors, individual businesses, consumer groups, and from individual service and product users i.e. the general public. It is important to note that this strategy is not INAB's organisational strategy, but instead, addresses accreditation nationally.

As part of the process of developing the new national accreditation strategy, we are now seeking input from interested stakeholders through a public consultation and, accordingly, we would be grateful to receive your input, suggestions and views regarding any strategic issues that you consider relate directly or indirectly to national accreditation and therefore should be incorporated in the national strategy.

The following areas may be used as prompts (these are suggested topics only, and should not limit your commentary):

- Quality Infrastructure: How can the Irish Quality Infrastructure (technology, systems, governance, organisations involved, capability) be strengthened in order to facilitate increased uptake of accreditation?
- Promotion: How should accreditation be promoted (i.e. to the market, within government, to the public) to ensure improved understanding, and the benefits of accreditation and accredited services are more widely known?
- Accessibility: How to increase accessibility for organisations to gain accreditation, and be less of a burden to those organisations looking to attain or maintain accreditation?
- Accreditation Future: In what areas would you consider there to be opportunities and threats related to accreditation in the next five years?
- Collaboration: What strategic partnerships would increase buy-in of the national accreditation strategy, to further benefit the Irish economy and society?
- Accreditation Services: How could current accreditation services be improved, and what new services can be incorporated to add value to clients, and to the economy and society?
