Kieran,

I refer to the letter of 12 June to the Secretary General of this Department regarding consultation on the implementation of the EU Directive on Consumer Alternative Dispute Resolution and the EU Regulation on Consumer Online Dispute Resolution.

This letter and accompanying documentation was circulated to all relevant Line Divisions and their agencies. No comments or observation were received except for the Commission for Aviation Regulation (CAR)

CAR observed that the matter was discussed at length with DJEI with a response from the then Head of Legal affairs Ms Pat Lamb emailing Cathal O’Gorman on 23th April 2012 indicating that as this office performed regulatory functions and was a national enforcement body that it was inappropriate for it to be an active player in the ADR mechanism.

It is suggested that in the area of transport that a single body such as the National Transport Authority might be a suitable body for such a role.

I will revert shortly with a response from the Tourism Development area.
