Item 1: Welcome

The Chair for this meeting was Lisa O'Brien, E-Commerce Head, Easons.

Item 2: Introduction by the Chair

The Chair introduced herself and the topics to be discussed and invited members to introduce themselves.

Discussion topics

- The challenges in the digital transformation of retail
- The opportunities that digitalization present
- Gaps where government support could be most beneficial
- Aim to anticipate future trends

Comments Arising

- Challenges
 - Businesses plan in 3-year cycles; often schemes to support businesses announced annually
 - Other costs living wages, pension auto-enrolment etc
 - Workers suspicious of technology role displacement threat
 - Covid pushed online need to plan for 'beyond online'
 - Arrival of Amazon.ie could put Irish retailers under pressure to improve their service levels (fulfilment & delivery) to meet customer expectations

 squeezed out
 - Upskilling training of retailers and retail workers very important member mentioned availability of training resources on .IE (The Great 28)
 - Awareness exists about benefits of AI but the practical application is lacking. How to apply AI practically to a business is key.

• Opportunities

- $\circ\,$ Technology can reduce inefficiencies; improve deliveries, use of self-service tills
- \circ Digitisation of processes assist stock control and ordering
- Using digital technologies to promote/market retailers

- Amazon.ie could provide small Irish retailers the chance to reach a wider audience online but upskilling required
- Al can be used to add value and grow business' top line

• Gaps/Supports

- Grants for improvement of operational efficiencies
- o ORS mark 2
- Look beyond online (retail scheme 2.0 that is inclusive of small businesses)
- Look at how technology can be used to lever 'shop local' campaigns at a national level
- Need to understand impact of digital transformation on workers

• Future Trends

- o Al
- o Training and skills development important

The Chair mentioned the development of a survey to gain an insight into the thoughts of the wider sector on the impact of digitalisation. The survey would target employers and employees.

Item 3: Presentation from Sarah Bealin, Digital Economy Policy and Data Access Unit on Grow Digital.

Sara Bealin informed members that the purpose of the Grow Digital Portal is to provide information to all enterprises on the benefits of digitalisation and provide a signpost to potential supports. Businesses can take a 5-minute self-assessment through the Portal to assess how 'digital ready' they are.
