Objective: The **Future of Retail – Green Transition** working group is tasked with identifying a set of achievable actions to feed into a Retail Action Plan that will be presented to the Minister for Retail, Damian English T.D. at the Retail Forum meeting on 08 June 2022.

1. Agenda Items

Action 1 - Promote the Sustainable Irish Retail Action Survey

The Group was provided with an update on the SIRA Survey. The Sustainable Irish Retail Action is led by Think Plan Do Consulting and BehaviourWise in partnership with Retail Excellence and Champion Green. The survey which was conducted within the retail sector will form the basis of a plan, under 10 key pillars of their retail sustainability platform, that will support consumer behavioural change towards more sustainable choices. Each pillar will have a simple set of information including facts, case studies, top tip and navigational guides.

It was agreed that this action is completed as the Department issued an email on 14 April with the 10 pillars under SIRA, along with a request for case studies under each pillar. *Comments arising:*

- Survey results will be published in 10 days, and the Retail Excellence representative will circulate the results to the working group members.
- The Guide for Retailers is scheduled to be launched on 8 June and will contain 25/30 case studies.

Action Complete

Action 2 – Provide stakeholder input in to the SEAI Retail Sector Energy Guide.

The Group was provided with an update on the SEAI Retail Sector Energy Guide which is due to be completed by early June 2022. Members were advised that they will be given an opportunity to provide input into the draft guide but due to the timeframe there will be a short response time. **Action Ongoing**

Action 3 – Map existing supports available to the retail sector in relation to the Green Transition

The Co-Chair gave an overview of the current draft list of supports and is awaiting feedback from the EPA on some additional supports. The revised list of supports will be issued to Working Group members in advance of the next meeting. It was agreed that this action should remain on the actions list.

Action Ongoing

Action 4 – Consider and identify how to best communicate supports via existing Government and business channels.

It was agreed that this action should remain on the actions list. Consideration could also be given to including information on supports in the trade presses i.e. Retail News, Checkout and Shelf Life. **Action Ongoing**

Action 5 – Assess and identify how best to gather data on engagement of the sector in the sustainability agenda

It was agreed that this action should remain on the actions list. *Comments arising:*

- Can representative bodies collaborate on this?
- Member advised that Ibec have a short-term working group concerning sustainability and they will forward information to the group on their activities.
- Members were advised that the other two Retail Forum Working Groups are also looking at data sources.
- Need to identify what data is required and what are the aims.

The co-chair gave an overview of the SME Green barometer and agreed to forward a copy to the Working Group.

Action Ongoing

Action 6 – Monitor the roll out of the Deposit Return Scheme

It was agreed that this action should remain on the actions list to show the benefits of the scheme, similar to the plastic bag levy.

Action 7 – Explore the feasibility of a pilot mentoring programme

It was agreed that this action should remain on the actions list *Comments arising;*

- Perhaps knowledge sharing (online workshops) rather than a mentoring programme could be considered
- Any programme needs to support small retailers in overcoming any fears and barriers in engaging with the sustainability agenda.
