# Sale of Tickets (Cultural, Entertainment, Recreational and Sporting Events) Act 2021

### **Purpose of the Act**

The Sale of Tickets (Cultural, Entertainment, Recreational and Sporting Events) Act 2021 came into force on 31 July 2021.

The purpose of the Act is to protect consumer rights and promote fairer access to tickets for cultural, entertainment, recreational and sporting events. The Act bans the resale of tickets to live events, matches and concerts in designated venues and for designated events, at a price above the original sale price, with an exemption for amateur sports clubs and registered charities for fundraising purposes. It requires certain information to be provided where either a primary ticket seller or secondary ticket seller sells or advertises for sale, tickets or ticket packages for such events.

## Scope of the Act

The Act provides that a venue operator or an event organiser may apply to the Minister to have a venue or event designated, thus prohibiting the sale of tickets above the original sale price in a "designated venue" or at a "designated event". The Act primarily provides for venues with a capacity to host 1,000 persons or more. However, the Minister may designate a venue with a capacity to host fewer than 1000 persons if, after consultation with the venue operator, he is satisfied that the venue will hold events which may give rise to the secondary sale of tickets or ticket packages for a price exceeding the original price. The Minister may also refuse an application or revoke a designation.

The Act provides that a contract term shall be void if it purports to exclude or limit the transfer or sale of a ticket or ticket package for a price not exceeding the original sale price.

The Act exempts charitable organisations and amateur sports clubs, where the sale of a ticket or ticket package has been approved by an event organiser, and the proceeds of the sale are used only for the purpose of funding the activities of the charitable organisation or sports group.

The Act gives effect, in relation to ticket sales, to specific provisions of Directive 2000/31/EC on certain legal aspects of information society services, in particular electronic commerce, in the internal market.

# **Policy Objectives**

The application of the Act is limited to those events that give rise to significant demand or where it would otherwise be in the public interest to prohibit above original price resale.

1. Promote fairer access to tickets for cultural, entertainment, recreational and sporting events

Prior to this Act coming into force, consumers would regularly see tickets for events being sold out in a matter of minutes, only to then see the same tickets being offered for sale on secondary ticket markets for prices far exceeding their original price.

The Act prohibits the sale, or the advertising the sale, of a ticket or ticket package for cultural, entertainment, recreational and sporting events by a secondary ticket seller above the original sale price, such that -

- when a venue is designated under the Act, the prohibition applies to all events held at that venue.
- when an event is designated under the Act, the prohibition applies to that specific event.

While previous monitoring of the secondary ticket market suggested that above original price resale of tickets accounted for a small proportion of events, such resales generally occurred for high-demand events. The designation of venues and events safeguards consumers by ensuring that the original price for a ticket is the maximum price a consumer is required to pay irrespective of when or where the ticket is bought. This in turn leads to more tickets being available to genuine consumers as the option for secondary ticket sellers to buy up tickets and offer the same ticket for resale at higher prices is restricted.

#### 2. Information requirements for primary and secondary ticket sellers

The Act requires that a primary ticket seller does not sell/advertise for sale, a ticket/ticket package for an event in a designated venue or a designated event without

providing information that the ticket/ticket package is for such an event and that its sale for a price exceeding the original sale price is prohibited.

The Act requires a secondary ticket seller, when advertising or offering a ticket/ticket package for sale on the secondary ticket market, to provide information on the original sale price of the ticket and the location of the seat or standing area to which, the ticket entitles the holder to gain admission.

These information requirements provide consumers with knowledge and assurance concerning the validity and price of their ticket.

#### 3. Exemption for charitable organisations and amateur sports clubs

An exemption applies to the sale/advertising for sale of a ticket/ticket package by or on behalf of a charitable organisation or an amateur sports club where its sale has been approved by an event organiser and the proceeds of the sale are used only to fund the activities of the charitable organisation or sports club.

#### 4. Register

The Act provides that the Minister will establish and maintain a register of designated events and venues and will make it publicly available. The Register for Designation of Venues and Events is updated as required and is available on the <u>Department's website</u> (please see Appendix 1 for the most up-to-date data).

The availability of the Register facilitates consumers who wish to buy a ticket for a designated event to be aware that the ticket being sold should be at the original sale price. The Register also makes the task of monitoring and enforcing the legislation more effective because designation applies to either the particular events or to the venues contained in the Register.

#### 5. Enforcement of the Act

Enforcement of the provisions of the Act falls within the remit of An Garda Síochána. A range of powers are available to the Gardai, including powers of entry and search and of examination, seizure and retention of evidence. A person who obstructs or interferes with a member of the Gardai or a person who refuses or gives a false name and address, is guilty of an offence. A conviction under the Act may include fines up €100,000 and/or imprisonment for a term not exceeding two years. Summary proceedings for an offence

under this Act can be brought at any time within two years from the date on which the offence was alleged to have been committed.

# **Operation of the Act**

The Act was fully commenced on 31 July 2021. The enactment has resulted in extensive coverage in print, broadcast and social media. Media coverage on the designation of larger venues, such as the Aviva Stadium, Croke Park and 3Arena, helped to publicise the benefits of the Act to event goers as well as event organisers and other venue operators.

Commencement of the Act coincided with the ongoing Covid-19 restrictions on live entertainment and hospitality. It also meant that the offices of many venue operators and event organisers were either closed or operating at reduced capacity. This initially resulted in a slow uptake in designation applications being made but as Covid-19 restrictions were eased, there was a marked increase in applications being submitted for designation of venues and events.

Engagement with venues with a capacity of over 1,000 took place at both Departmental and Ministerial level, outlining the key objectives of the Act and the benefits of being designated. This proactive approach resulted in the majority of venues seeking designation, with the recognition that this would best serve their own customer base.

To date, the following designations have been granted (see Appendix 1 – the Register of Designations) -

Venues designated: 27 Events designated: 42

The designation process has worked well since its inception, with no delays being encountered, and resulting in positive feedback received from venue operators and event organisers.

So far, no enforcement actions have been taken under the Act.

At a recent meeting with officials who are considering introducing similar legislation in the UK, Irish officials shared the learnings of implementing such legislation. Industry stakeholders were also in attendance and one Irish online platform representative

stated that the Act appeared to be working well in curbing above face value secondary ticket sales on online platforms. The representative was also confident that, while the Act might lead to increased street touting, the Gardaí would be well placed to deal with this as they were generally present outside major sporting events and concerts.

This is a positive endorsement of the operation of the Act and means that the objectives of the Act are being met whereby genuine fans can attend events at affordable prices.
